Specific Location	On the north side of Circleville Avenue (Lockbourne Eastern) Viking Way the project will begin at the address of 329 East Main Street. The water line will proceed south for a distance of until +2277 feet until the water line reaches the Earnhart Hill Water/Sewer District water line at 15399 Lockbourne Eastern Road.
Identify The Problem	A water connection with Earnhart Hill Water/Sewer District will accomplish two objectives. It will provide an additional source of potable water if our water system is down. It will provide additional potable water of between 0 to 150,000 gallons per day.
Project Scope	The Scope of the Project is to provide a connection between Ashville's potable water and Earnhart Hill's potable water.
Additional Notes from Applicant	The benefit of this connect extends beyond Ashville and the Earnhart Hill Water/Sewer District. Ashville already has a connection with South Bloomfield to our west. Earnhart Hill Water/Sewer District has a connection with the City of Circleville. This connection provides regional capacity in Pickaway County.
Project Notes	Christopher Tebbe, the project engineer considered both open cut and directional bore. He also provided a 8 inch and 12 inch line option during the preliminary design of the project.
