Improvements Grant/Loan

Dear Ms. Spiker:

Enclosed is the District 17 Round 33 Application and supporting material for the Village of Ashville.

In 2010, the Village of Ashville approached the Ohio Department of Transportation (ODOT) about a problem with the disappearance of curbs in the downtown area of Ashville. This problem was approaching critical mass with water runoff and the ability to move stormwater from vital areas of downtown. At that time they committed to working with Ashville in resolving this issue. Last year they suspended a 2017 resurfacing project to develop a project that is now being submitted to the Ohio Public Works Commission (OPWC). This is a project that will be between Jefferson Avenue and Station Street on State Route 316. We hope to be successful in obtaining the requested funding. In addition to this funding requested, we have obtained commitments from ODOT and the Pickaway County CDBG. By October 12, 2018 there will be a project webpage. That webpage can be accessed through our website at www.ashvilleohio.gov.
