

# **ORDINANCE 2022-15**

## OF THE VILLAGE OF ASHVILLE

AN ORDINANCE TO AMEND 2000-11 AND 2012-03 TO REFLECT CHANGES IN THE VILLAGE OF ASHVILLE INSURANCE BENEFIT. THIS ORDINANCE DESIGNATES CERTAIN VILLAGE EMPLOYMENT POSITIONS AS ENTITLED TO MEDICAL AND HOSPITALIZATION INSURANCE, AND TO DECLARE AN EMERGENCY.



Now, THEREFORE, Be it ordained by Council of the Village of Ashville, Pickaway County, and State of Ohio:

#### **SECTION ONE:**

Employees working for the Village of Ashville are entitled to medical and hospitalization insurance. See Section Two for the breakdown of coverage.

#### **SECTION TWO AMENDED:**

The following is the current Chapter 155.08 Insurance:

Contributory medical and hospitalization insurance is made available to all Village employees for individual coverage through a group plan. Participation in the plan is at the employee's discretion.

- (a) Contributory insurance is also made available for family coverage with the Village paying a portion of the family coverage.
- (b) Any, and all, part-time employees not working a scheduled regular 40-hour week shall not be eligible for coverage under the Village Group Insurance Plan.

The Chapter 155.08 Insurance will be amended to the following:

Contributory medical and hospitalization insurance is made available to all Village employees for individual coverage through a group plan. Participation in the plan is at the employee's discretion.

- (a) Contributory insurance is also made available for family coverage with the Village paying a portion of the family coverage.
- (b) Any, and all, permanent part-time employees will be eligible for a prorated coverage equal to the percentage under a scheduled regular 40-hour week under the Village Group Insurance Plan.

### **SECTION THREE:**

That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the Village of Ashville, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
