


RESOLUTION 01-2023

OF THE VILLAGE OF ASHVILLE





WHEREAS, the Ohio Revised Code (ORC) 4511.21 establishes statutory speed limits on State Routes within Municipalities for Business District of 25 mph ORC 4511.21 (2), Urban District of 35 mph ORC 4511.21 (3), and Outside Urban District of 50 mph ORC 4511.21 (6); and

WHEREAS, the Village of Ashville has a responsibility for the health and safety of its residents and businesses; and

WHEREAS, the Village of Ashville periodically reviews the safety of the streets in the Village of Ashville; and

WHEREAS, a developer is in the process of building a 232-apartment unit on the southside of State Route 752 between CSX and Norfolk Railroad within the municipality limits of Ashville; and

WHEREAS, the Village Engineer, the Service Department, and Administration is recommending an adjustment to the speed limits on State Route 752.

NOW, AND HEREAFTER BE IT RESOLVED BY THE VILLAGE COUNCIL, VILLAGE OF ASHVILLE, PICKAWAY COUNTY, STATE OF OHIO THAT:

SECTION ONE

The Village of Ashville will designate the area between CSX and Norfolk as an Urban District under ORC 4511.21(O)(5) with a speed limit of 35 mph. West of CSX to the municipality limits on State Route 752 with a speed limit of 50 mph, see exhibit. All notification signage is authorized based upon ODOT Standards, ORC, and Village of Ashville Ordinances.

SECTION TWO

The Village of Ashville is requesting that areas on the north side of State Route that are not in the municipality limits be adjusted to have a consistent speed limit in conformity with ORC 4511.21 (M)(1). A copy of this resolution will be provided to all jurisdictions involved, Harrison Township and the Ohio Department of Transportation (ODOT).

SECTION THREE

That this resolution is hereby declared to be an emergency resolution and necessary for the preservation of the financial peace, health, safety, and general welfare of the citizens of the Village of Ashville.

Therefore, this resolution will take effect upon passage.
