



ORDINANCE 2024-03

OF THE VILLAGE OF ASHVILLE

AN ORDINANCE TO AMEND CHAPTER 522.04 TREE ADVISORY BOARD AND DECLARING AN EMERGENCY.



WHEREAS, the Council of the Village of Ashville, Ohio regulates by ordinance weeds, litter, and trees; and

WHEREAS, it becomes necessary on occasion to adjust those regulations.

WHEREAS, the following changes will be made to Chapter 522.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ASHVILLE, OHIO THAT:

SECTION I - Changes to Chapter 522.04 (a) Membership

The Board shall consist of seven members approved by Village Council. Members of the Board will serve without compensation. This section will be changed to at least three (3), but not more than five (5) persons, residents of the Village, who shall be appointed by the Mayor with the approval of the Council.

SECTION II – EMERGENCY

That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements, and shall go into full force and effect immediately upon its passage by Council.
