Regarding: Director's Final Findings and Orders NPDES Pickaway County 4PC00005

Dear Enforcement:

The Village of Ashville is responding to the first request Orders:

"Respondent shall minimize infiltration and inflow (I & I) of ground and surface water into its sanitary sewer collection system to the extent necessary to provide consistent compliance with Respondent's NPDES permit and any modification or renewal thereof and shall upgrade its collection system as expeditiously as practicable, but not later than the following schedule:

- a. Within thirty (30) days of the effective date of these Orders, Respondent shall submit a brief description of corrective actions, locations and a schedule ("Plan") for collection system improvements to Ohio EPA in accordance with Section X. of these Orders for review and acceptance;"

The Village of Ashville is dividing the work on I&I into three seamless parts for illustration purposes. Those parts are:

1. The "Ongoing Infiltration/Inflow Reduction Plan 2014 Procedure Manual"
2. The "2014 Inflow and Infiltration Toolbox"
3. The "Inflow and Infiltration Dashboard"

The following page is a summary of these parts and what is enclosed will be a more detailed plan, toolbox and dashboard under development. A Project Planning Timeline is also enclosed. We anticipate I & I to be ongoing therefore will be a program under review and updating.
