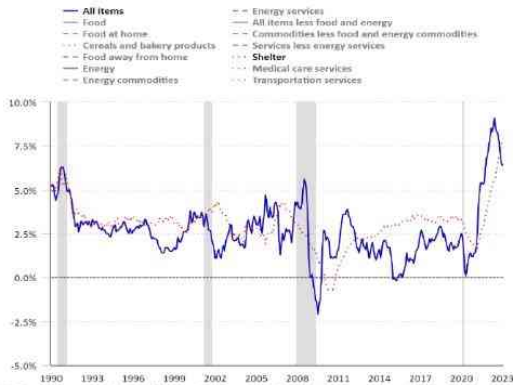

In 2006 the Village of Ashville began the process of replacing analog water meters with the Neptune Radio Read. In 2021 we placed the 360 SmartMeter software into operation. This allows us to collect usage information every month, day, and hour. We have replaced 1,179 meters and have 355 additional meters to replace with the Neptune SmartMeter. A new software billing system will allow Ashville to provide that information to our customers. It will also provide different options for paying utility bills.

Muni-Link Utility Billing a Link Computer Corporation. It is a complete, user friendly, and intuitive utility billing software solution that will better integrate our existing meter software with the Muni-Link billing.

- ◊ E-billing and built-in CASS certification saves time and money.
- ◊ The customer portal provides you access to your utility information.
- ◊ Payments made via the portal post automatically into your account.
- ◊ It is cloud-based therefore, you can access your information 24/7 from anywhere.

It is a utility software program. The Village of Ashville will later expand billing capabilities. These capabilities may include planning & zoning fees, park reservation fees, mayor's court judgements, building fees, and some tax fees. This system also offers other important features:

**Data Security**

Their software is hosted at a Tier-4 World-Class Data Center, keeping data safer. 24/7 onsite security officers, CCTV, biometric and magnetic key card access are just a few of the security measures in place.

**Backup and Disaster Recovery**

Included in this service is a monthly subscription fee which provides automatic backup of data. This will allow for us to restore data that could be lost during a disaster.

**Ongoing Development**

- ◊ Monthly Muni-Link enhancements are created based on customer feedback

### Utility Fee Update for Consumer Price Index (CPI)

Consumer Price Index Increase for 2022 is 6.4%. Based upon Ordinance 2009-03, which provided for keeping revenue in alignment with expenses, the water charge will go from \$3.80 to \$4.09 and the sewer charge will go from \$7.72 to \$8.30. The following information reflect the changes you should see in the next bill.

This will be the second year since 2014 we have not had to increase debt service for the Water Resource Recovery Facility.

**ORDINANCE 2009 - 03**

**THIS IS AN ORDINANCE AUTHORIZING THE CHANGE IN UTILITY RATES IN THE VILLAGE OF ASHVILLE, AND DECLARING AN EMERGENCY.**

WHEREAS, the Council of the Village of Ashville, Ohio authorizes by ordinance the rates charged for the refuse utility of the Village; and

WHEREAS, it becomes necessary on occasion to adjust those rates.

WHEREAS, the cost of providing utility services will be linked to the Consumer Price Index and will increase by that percentage at the conclusion of a year to be added on the next full-month.

WHEREAS, this rate increase will allow revenue to keep pace with expenses.

NOW, AND HEREAFTER BE IT ORDAINED BY THE VILLAGE COUNCIL, VILLAGE OF ASHVILLE, PICKAWAY COUNTY, STATE OF OHIO THAT:

SECTION ONE

The rate structure for water and sewer charges found in Chapter 929. Water, Sewer, and Stormwater Rates will be adjusted annually based upon the Consumer Price Index.

SECTION TWO

This Utility Rate change will become effective during the first full month after the December Consumer Price Index is announced and annualized. That rate will be communicated to the residence before it becomes effective.

SECTION THREE

That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Village and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of rates authorized by this ordinance to the officials and residents of the Village, so as to facilitate administration, daily operation and avoid practical and legal entanglements, and shall go into full force and effect immediately upon its passage by Council.

**AN ORDINANCE TO AMEND ORDINANCE 929.02 (2009-12) TO CHANGE THE CHARGE FOR WATER SERVICES IN THE VILLAGE OF ASHVILLE. THIS CHANGE WILL NOT CONFLICT WITH ANY OHIO REVISED CODE (ORC) LIMITATIONS AND DECLARING AN EMERGENCY.**

WHEREAS, the Council of the Village of Ashville, Ohio authorizes by ordinance the rate of charge for utilities within and/or without the Village; and

WHEREAS, it becomes necessary on occasion to adjust those charges.

NOW, AND HEREAFTER BE IT ORDAINED BY THE VILLAGE COUNCIL, VILLAGE OF ASHVILLE, PICKAWAY COUNTY, STATE OF OHIO THAT:

SECTION ONE

That the following rate structure will be used as a replacement for Chapter 929.02 Water:

The rate increase of \$0.26 per thousand gallons of water will be used to pay the cost of placing our two Village of Ashville water towers on a maintenance program.

This Ordinance deals only with usage of water. All other sections of Chapter 929 Water and Sewer Rates remain in affect and therefore fully enforceable.

AN ORDINANCE AMENDING ORDINANCE 2019-10, 2018-08, 2017-09, 2016-07, 2014-04, 2015-04 AND 929.02 (96-13, 2006-06, 2009-03, 2010-07) FOR A DEBT SERVICE CHARGE FOR THE WATER RESOURCE RECOVERY FACILITY EXPANSION PROJECT IN COMPLIANCE WITH OHIOEPA FINDINGS AND ORDERS FOR THE VILLAGE OF ASHVILLE, AND TO ALTER THE CHARGE FOR WASTEWATER IN THE VILLAGE OF ASHVILLE. THIS AMENDED ORDINANCE WILL NOT CONFLICT WITH THE OHIO REVISED CODE (ORC) LIMITATIONS AND DECLARING AN EMERGENCY.

NOW, AND HEREAFTER BE IT ORDAINED BY THE VILLAGE COUNCIL, VILLAGE OF ASHVILLE, PICKAWAY COUNTY, STATE OF OHIO THAT: SECTION ONE - That the following rate structure will be added to Chapter 929.05 Sewer Rates:

AN ORDINANCE TO AMEND ORDINANCE 2020-09 CHANGING THE SYSTEM CAPACITY CHARGE FOR WATER, FIRE SUPPRESSION, AND WASTEWATER IN THE VILLAGE OF ASHVILLE. THIS CHANGE WILL NOT CONFLICT WITH ANY OHIO REVISED CODE (ORC) LIMITATIONS AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Ashville, Ohio authorizes by ordinance the system capacity charged for the utilities within and/or without the Village; and

WHEREAS, it becomes necessary on occasion to adjust those charges.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ASHVILLE, PICKAWAY COUNTY, OHIO THAT:

**SECTION ONE**

That the following rate structure will be used as a replacement for Chapter 929.06 Water system capacity charge and Chapter 929.07 Sewer system capacity charge:
