- Remove and dispose of the existing pumps and associated equipment.
- Excavate and remove and dispose of the pitless adapter and cut the well casing off at approximately 4 feet below ground level.
- Excavate and remove the existing concrete vault to a minimum depth of 4 feet below the existing ground level.
- Transport concrete vault materials and excess soil to a site provided by the Village of Ashville.
- Backfill and seal the entire well bore with bentonite clay then pour a concrete cap on top of the sealed well casing.
- Backfill the excavation with clean fill materials.
