Computer or Broadband

As schools begin the 2020-2021 year with remote learning or hybrid models, the Central Ohio Broadband Access Pilot Program is providing low-income, K-12 students and their families with low-cost internet access.

The lack of a reliable and affordable internet connection and device to access the internet makes remote learning impossible and causes more students to fall behind. This program seeks to address the inequities that exist in our community.



The program will provide refurbished computers and hotspot devices for families to set up an internet signal using cell phone signals. No new infrastructure or professional installation required.

Transportation



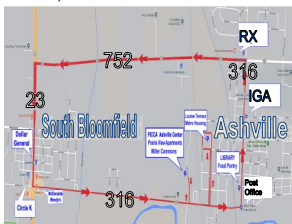

Rent/Utilities/Mortgage

The Pickaway County Community Action Organization (PICCA) through the CARES Act funding provide rent, utility (water and sewer) and mortgage assistance.

Ohio has allocated money from the Coronavirus Relief Fund, made available through the CARES Act. It will help those who have experienced economic hardship from COVID-19 with past due rent, mortgage, water, and sewer payments. Households with an annual income at or below 200% Federal Poverty Level, and who are past due on rent, mortgage, water, and/or sewer payments are eligible. For a family of 4, that annual income level is up to \$52,400.

- Copies of Social Security cards or verification for each household member
- Proof of income
- Hardship due to COVID-19 pandemic

- Notice of past due rent, mortgage (including taxes and insurance), and/or copies of utility bills demonstrating past due or disconnection status



3 Complete your application

PICCA will walk you through the application and approval process



4 Approval & Payment

If approved, payment will be sent directly to your landlord, mortgage company, or utility provider



The Legislative Corner

This section provides the title to Ordinances and Resolutions being considered by Village Council. To read the entire text go to our website. Enacted legislation will be found under "Village Government"; and Legislation that is being considered can be found under "Village Council—Agenda".

- ◆ Ordinance 2020-08 an Ordinance Authorizing the Village Administrator or Mayor to execute an Agreement with the Teays Valley School District for Use of the Village's Water Tower for Placement of a Communication Antenna, and Declaring an Emergency.
- ◆ Ordinance 2020-09 An Ordinance to Amend Ordinance 2008-07 Changing the System Capacity Charge for Water and Wastewater in The Village of Ashville. This Change Will Not Conflict with any Ohio Revised Code (ORC) Limitations and Declaring An Emergency.
- ◆ Ordinance 2020-10 An Ordinance to Make Temporary Appropriations for The Next Year's Expenses and Other Expenditures of the Village of Ashville, State of Ohio, Based upon the Certificate of Estimated Resources Issued by the Pickaway County Budget Commission for the Fiscal Year Beginning January 1, 2021, and Declaring an Emergency.

Drop Box (Good for Covid-19)

Now we have a drop box located in Administrative Office parking lot at 200 Station Street East.

Please make sure you place your bill payment (Utility, Tax, Zoning, Building, & Mayor's Court) so that the posting of your payment will not be delayed. Payments put in the box on the due date will be credited with that day's date and will not be considered a late payment. We recommend paying by check or money order when using this method of payment.

Anything put in the box after 8:00 a.m. the day after the due date will be assessed a late fee. This fee will not be removed.

Seasonal Advice from the Ashville's Service and Police Department



While the weather has been mild, we are preparing the village for winter. The goal of the service department is to maintain the safe flow of traffic. The crews work around the clock as needed for snow plowing and salt application. The snowplows will clean the streets from curb to curb. You can help the service department during sleet, hail, ice, and snow removal. This can only be done if cars are not parked along the curb. Please remove car (s) to a place that has been plowed. They can be returned once plowed.

Main and secondary roads are given first priority for plowing and salting to assure emergency accessibility and to ease traffic congestion. Residential streets are plowed afterwards.

- * Primary Streets = Main, Long, Station, Circleville Ave., & State Route 752
- * Secondary Streets = Jefferson, Miller, Scioto, Cromley, East, Powell, Randolph, Walnut, Plum and Park.

After Primary and Secondary Streets all remaining streets are plowed.

Snow Parking Ban - Parking is prohibited in Village Business District when snow has accumulated to a depth of two (2) inches. Signs are posted in these designated areas.

Property owners are responsible for snow and ice removal from sidewalks in front of their property. Depositing of snow or ice onto any public street or sidewalk is prohibited. Snow must be kept on the property it falls. Snow from your driveway may not be taken across the street. Also, please keep fire hydrants and storm sewer drains clear.

If you need the Service Department, call 983-6367 and ask for Greg Sturgill. He is our Chief of the Service Department. He will return your call.
