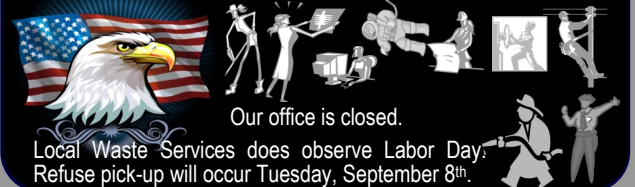
Fire Hydrants will be Flushed on Sunday, September 29th 9:00 pm to 1:00 am (weather may cause delays)

The Water Department uses fire hydrants to flush out sediment, rust, stale water, etc. from mains. While most of the rust is flushed from the pipe, a small amount will remain suspended in the water. You may have some reduced pressure and darker colored water during this process. The discoloration will dissipate in a few hours. If discoloration occurs, let your water run until it clears. One word of caution: Rust will stain light colored laundry. Please be sure that both your cold and hot water are rust-free before you launder light colors. In the event that such staining occurs, there is a remedy. Most grocery and hardware stores carry laundry aids, which remove rust stains. We have a Rust Stain Remover at the office called "Super Iron Out". If you happen to get this message late, come to 200 East Station if you need to remove iron stain from your clothing. **We want to reemphasize the water is safe for drinking purposes but caution should be used if water is being used on items that are sensitive to discoloration.**

This is a joint project between Ashville, ODOT, OPWC, CDBG, and AMAZZ Construction. Project should be completed by October 15th.

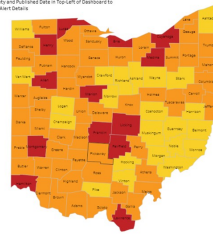


Ashville Covid-19 & Restart Update

Police Chief George Report

On August 17th in addition to the below July Police Report, Chief George introduced Officer Adam Bour to Village Council and the Community. He is pictured to the right with Mayor Wise giving him the oath of office. He graduated from Hopewell Loudon High School in Bascom, Ohio. He obtained a Police Academy Degree from Owens Community College and is currently enrolled at Tiffin University going for a Bachelors Degree in Criminal Justice.



Before coming to Ashville he work for the Village of Green Spring Police Department. Officer Bour stated, "I picked Ashville because I've grown up, lived and worked in rural type communities that have a strong support for law enforcement."

At this meeting two Auxiliary Officers are retiring. Officer Richard Cutshall served the Village for 20 years and Officer Mike Domineck for 18 years. They both helped in a

life saving event involving a house fire on Long Street. That night Officer Cutshall and Domineck went to a store and got the children that lived in the home stuffed animals. Both Officers also helped retrieve items that the kids wanted from the home.

The Officers assisted with the arrest warrants in the 2008 and 2009 Drug Round Up.

We wish Officer Cutshall and Domineck well in their future endeavors.



Last Month's Newsletter Utility Fee Reminder

Debt Service increased \$1.80 and CPI 0.25c per 1,000 gallons. Therefore, the chart below indicates the impact on your bill. Look at the usage times \$2.05.

- ◆ 1,000 gallons = \$2.05 increase
- ◆ 2,000 gallons = \$4.10 increase
- ◆ 3,000 gallons = \$6.15 increase
- ◆ 4,000 gallons = \$8.20 increase
- ◆ 5,000 gallons = \$10.25 increase
- ◆ 6,000 gallons = \$12.30 increase
- ◆ 7,000 gallons = \$14.35 increase
- ◆ 8,000 gallons = \$16.40 increase
- ◆ 9,000 gallons = \$18.45 increase

The stormwater fee remains \$3.00 and the residential Recycle/Refuse Fee is \$16.72.

This new charge is reflected in this bill.
