  - To operate within the meaning of Section 501(C)(3) of the Internal Revenue Code

- ◆ 2020-01 An Ordinance Authorizing the Village Administrator and Fiscal Officer to execute a personal Service Agreement for Legal Services with Mark Landes, and Declaring an Emergency
- ◆ 2020-02 An Ordinance to Amend 2000-11 and 2009-20 to reflect Changes in the Village of Ashville Pay Ordinance. This Ordinance Designates Certain Village Benefits as 155.05 Sick Leave and Other Time as 155.07 Personal Time. This Ordinance Establishes a New Formula for the Generation of Sick Leave and Personal Leave, and to Declare an Emergency.

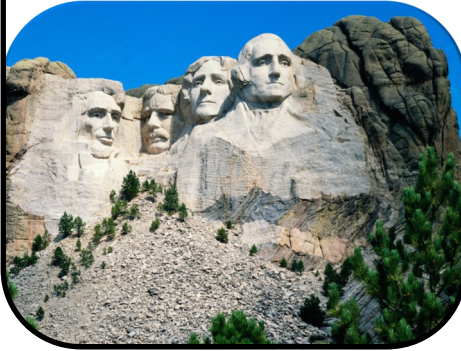
**ASHVILLE VISION STATEMENT**
