

### Update on Utility Billing and SmartMeters

The Village of Ashville is in the process of completing conversion to the Neptune 360 Smart Meter and updating our billing process

with Continental Utility Solutions, Inc. (CUSI). We now get a daily report that looks like this:



The Neptune 360 Dashboard allows us to detect High Usage and Continuous Consumption information. That information is used to communicate what has been detected as water usage every hour. This allows us to pass this along to our customers. It is important that we can reach you with this information. Please call 740-983-6367 to update your phone number or email address. You can also send a email to www.ashvilleutility@ashvilleohio.gov.

Since Neptune and CUSI are two separate systems one exports information to the other. For July billing, there was a problem with the data that was received by CUSI, which was corrected in August. The bills received with this mailing reflect actual integrated transmission and reception of your usage from August 30 through September 28. We will attempt to ensure that the monthly days charged are as equal as possible. Thank you for your patience as we work through this operational change.



## Trick or Treat

#### **Trick-or-Treat Safety Tips**

When taking your children out this Halloween for Trick-or-Treat, remember a few things that can help to keep them safe.

- Make sure that their costumes do not impede their ability to move or cause a tripping hazard.
- Make sure that the children have a full field of view when wearing masks.
- ★ Hem your costumes so you don't trip and fall.
- Apply reflective tape to your Halloween costumes.
- Avoid cumbersome masks. Use make-up instead.
- Use only hypoallergenic and non-toxic makeup.
- ★ Wear comfortable, practical shoes.
- Double tie your shoelaces so you don't trip.
- Watch for traffic when crossing the street or walking in areas where there are no side walks.
- ★ Do not go inside the houses of people you do not know.
- ★ If your children are going Trick-or-Treating without an adult, make sure they go in groups, never alone.
- Check all candy before you allow your children to eat anything. Discard any candy or items that are open or otherwise appear to have been tampered with.

## & Covid-19

If you choose to participate in your community's trick or treating, please use these health and safety tips for a safe and happy Halloween during COVID-19.

#### **Trick or Treaters**

- Perform health screen prior to leaving—stay home if you or your child feels sick or is at high risk of complications.
- Wear a face mask, except for children under two years of age and individuals with medical exceptions.
- Make sure your face mask completely covers your nose and mouth at all times.
- ★ Maintain social distance of at least six feet from other groups.
- ★ Trick or treat with people in your own household.
- Avoid doors with a cluster of people. Stay back and wait until nobody else is at the door.
- \* Participate in Halloween activities outdoors if possible.
- Avoid large parties, gatherings and indoor activities.
- \* Collection bag should have wide mouth to allow giver to drop treat inside
- make Bring hand sanitizer to use between houses.
- Take only wrapped candy or treats.
- \* Wash your hands when finished trick or treating before eating candy.

#### **Treat Givers**

- Do not give out candy if you or anyone in your household feels sick or is at high risk of complications.

- Put treats in individual baggies and lay them out instead of putting them in a large bowl.
- Provide hand sanitizer for trick or treaters.
- Wash your hands frequently.
