- ♦ Ordinance 2022-19 An Emergency Ordinance Amending Ordinance 2022-08 Declaring the Improvement of Certain Real Property Located in the Village of Ashville, Pickaway County, Ohio to be a Public Purpose; Declaring such Property to be Exempt from Real Property Taxation; Designating Specific Public Infrastructure Improvements that, Once Made, Will Directly Benefit the Parcels for Which Improvement is Declared to be a Public Purpose; Requiring Annual Service Payments in Lieu of Taxes; Establishing a Municipal Public Improvement Tax Increment Equivalent Fund; Authorizing the Execution of a TIF Agreement; Providing Related Authorization Pursuant to Ohio Revised Code Sections 5709.40(B), 5709.42, 5709.43, 5709.82 and 5709.83; and Declaring an Emergency.
- ♦ Ordinance 2022-20 An Ordinance Amending Ordinance 2022-07 and Approving the Execution of a Community Reinvestment Area Agreement Between the Village of Ashville and Exel Inc., A Massachusetts Corporation, D/B/A DHL Supply Chain (USA), Execution of a School Compensation Agreement with Teays Valley Local School District and Exel Inc., Repealing Resolution 06-2018 Adopted July 23, 2018 and Terminating the Related Agreements and Declaring an Emergency. Resolution 19-2022 A Resolution Authorizing the Village Administrator and Fiscal Officer to Execute an Agreement and/or Purchase Order with Pritchard Electric to Install Park Lights and to Execute Other Contracts as Required.
- ♦ Ordinance 2022-21 An Ordinance to Make Temporary Appropriations for The Next Year's Expenses and Other Expenditures of the Village of Ashville, State of Ohio, Based upon the Certificate of Estimated Resources Issued by the Pickaway County Budget Commission for the Fiscal Year Beginning January 1, 2023, and Declaring an Emergency.
- ♦ Ordinance 2022-22 An Ordinance to Amend 2003-11, 2006-02, 2006-08, 2009-09, 2009-20, 2013-02, 2013-05, 2014-05, 2016-06, 2017-05,2019-01, 2019-09, 2019-18, 2020-02, 2020-12, and 2022-14 to reflect Changes in the Village of Ashville Pay Ordinance. This Ordinance Designates Certain Village Employment Positions as Hourly Positions and Salaried. It Establishes Minimum and Maximum Pay Rates of Compensation for such Persons Employed in such Positions, and to Declare an Emergency.
- ♦ Ordinance 2022-23 An Ordinance to Amend 2005-10 to Reflect Changes in the Village of Ashville Impact Fee Structure. This Ordinance Designates Certain Village Fees for Government, Parks, Police, Streets, and Fire; and to Declare an Emergency.

# **Seasonal Advice from the Village of Ashville Service & Police Department**

While leaf pick-up is just being completed, we have been preparing for winter. The goal of the service department is to maintain the safe flow of traffic. The crews work around the clock as needed for snow plowing and salt application. You can help the service department during sleet, hail, ice, and snow removal. This can only be done if cars are not parked along the curb. Please remove car (s) to an area that has been plowed. They can be returned once plowed.

Main and secondary roads are given first priority for plowing and salting to assure emergency accessibility and to ease traffic congestion. Residential streets are plowed afterwards.

- Primary Streets = Main, Long, Station, Circleville Ave., & State Route 752.
- Secondary Streets = Jefferson, Miller, Scioto, Cromley, East, Powell, Randolph, Walnut, Plum, Park, and all remaining streets.

**Snow Parking Ban** - Parking is prohibited in Village Business District when snow has accumulated to a depth of two (2) inches. Signs are posted in these designated areas.

Property owners are responsible for snow and ice removal from sidewalks in front of their property. Depositing of snow or ice onto any public street or sidewalk is prohibited. Snow must be kept on the property it falls. Snow from your driveway may not be taken across the street. Also, please help keep fire hydrants and storm sewer drains clear.

If you need the Service Department, call 740-983–6367 and ask for Greg Sturgill. (We would like to call your attention to pot holes. If you happen to see them, please call 983-6367). Chief George can be reached at 740-983-3112 for nonemergencies.

We thank the dedicated drivers for working long cold hours to make our streets safer to drive.
